may exist in Radford for Shah.

b) Wades building Mr. Edwards reported that the building should be completely

empty by May 1 and ready to show to prospects.

c) 232 Property- Mr. Davis reported that Sam Bell had agreed to allow the EDA to

market both the EDA and his property together as one 3 acre site. Mr. Edwards requested the EDA authorize the purchase of a sign to advertise the property as for sale and to also authorize funds to

clear the property.

Motion: Mr. Davis moved that Mr. Edwards be allowed to erect a

sign and to hire a contractor to clear the site for an amount not to exceed \$2,500 as long as Mr. Bell would agree to split the cost

equally. Dr. Graham seconded the motion.

d) TechLab Mr. Edwards reported that on December 12, 2011 City Council

amended the restrictive covenants on the Radford Industrial

Center for TechLab that increased the construction time frame to 36 months. Techlab is requesting a waiver and modification as to the extension of time for the Radford Industrial Center Lot 11 for an additional 60 months from the current date of December 12, 2014 to December 12, 2019. It is TechLabs intent to pursue commercial development and usage of the parcel within the course of the requested waiver time.
